I. COMPANY PROFILE

Bharat Sanchar Nigam Ltd. (BSNL) was incorporated in September, 2000 under the Indian Companies Act, 1956 with the objective to take over the business of providing telecom services and network of the erstwhile Department of Telecommunications with effect from 1st October, 2000. The Company is providing Telecom Services throughout the country except Delhi and Mumbai. BSNL is a schedule 'A'/ Miniratna CPSE with the administrative jurisdiction of Department of Telecommunications. The company employed 60104 regular employees (Executives 29750 and Non-executives 30354) as on 31.03.2023.

Its Registered and Corporate offices are at New Delhi.

The authorized and paid up capital of the Company was Rs. 150000 crores and Rs. 38886.44 crores (including Preference Share Capital of Rs. 7500 crores) respectively as on March 31, 2023. The shareholding of the Government of India in the Company is 100%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Enterprise) is a member of Board of Directors and reports to the Chairman and Managing Director. He/She is Head of the Enterprise Business unit and is responsible for business from big corporate customers and small & medium enterprises (SMEs). He/She is responsible for all aspects of the business including Product design, Product pricing, Sales, Marketing, Customer service, Service Delivery/Service Assurance, adherence to service level agreements (SLAs),

Billing, Collections & Revenue Assurance and also for wholesale business along with planning, expansion, upgradation, operations, maintenance and management of core network assets (transmission media and other core network elements). He/She is responsible for generating revenue and driving profits in the enterprise and wholesale business. 'He/She is responsible for handling international Long Distance (ILD) voice business, procurement of International Internet bandwith & Satellite Communication business and USOF funded Submarine cable Projects and Satellite Projects.'

Applicants should possess cumulative experience/exposure for at least 5 years during the last 10 years in Telecom sector at a senior level of management in a large organization of repute.

3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
